

## **GUIDELINES FOR MEMBERSHIP**

- All entities wishing to become Members of International Council of Traditional Sports and Games (ICTSG) must apply to the TSG Secretariat by submitting a signed Membership Application Form along with relevant supporting documents in duplicate sets (*the original copy to be sent via courier and a scanned copy to be emailed at the addresses provided below*).
- The Application shall be assessed by the ICTSG Affiliation and Scrutiny Committee, pursuant to the evaluation of which the Chairperson of the Affiliation and Scrutiny Committee shall submit his/her recommendation to the President of the ICTSG.
- The ICTSG President may, in exercise of his/her discretion, issue a Provisional Membership Certificate until a Full Membership status is awarded to the Applicant entity by the General Assembly at its next session.
- In case an Application is rejected, the Chairman of the Affiliation and Scrutiny Committee shall provide detailed reasons of such refusal to the ICTSG President who, upon receipt of a written request from the Applicant, may inform them of the same.
- The Application Processing Fee, for all Groups, is a non-refundable amount of US\$ 200/- (United States Dollars Two Hundred only).
- The Registration Fee, which shall be a one-time payment, amounts to US\$ 1000/- (United States Dollars One Thousand only) for Group B, and US\$ 2300/- (United States Dollar Twenty-three Hundred only) and shall only be refunded to an Applicant(s) whose Membership Application is rejected by the Affiliation and Scrutiny Committee.
- All Applicants are required to pay the Processing and Registration Fees amounting to a total of **US\$ 1,200/- (United States Dollars One Thousand and Two Hundred only) under Group-B & US\$ 2,500/- (United States Dollars Twenty-five Hundred only) for Group-C** via bank transfer into the account designated by ICTSG, the details of which are provided hereinbelow.
